


PURSUANT TO §2-2-6(A) of the Prairie Band Potawatomi Nation Law and Order Codes vesting authority in the District Court to “Be responsible for creating and maintaining the regulations and rules of the Court, not conflicting with the Tribal Codes for the orderly and efficient administration of justice. Such rules must be filed in the office of the Court Clerk before becoming effective”.

The District Court, in accordance with Prairie Band Potawatomi Nation Law and Order Codes, §17-5-1 (C), hereby establishes a court cost of \$25.00 for all traffic citations and criminal matters and additional costs as follows:

- a. Criminal matters that involve violent crimes and/or damage to property shall be assessed an additional court cost in the amount of \$25.00 which shall be paid into the Victim Assistance fund.
- b. Any drug or alcohol related criminal matters and/or traffic matters shall be assessed an additional fee of \$25.00 that shall be paid into the Healing to Wellness Court.

This will remain in effect until otherwise directed by further rules of the District Court or until amended by the Prairie Band Potawatomi Law and Order Codes.
