Treatment services: Outreach assessment and referral to an alcohol and drug program with a licensed alcohol/drug counselor, Narcotics Anonymous, Alcohol Anonymous and Al-a-non for family of addicts.

Traditional Healing Services: Sweat Lodge Ceremonies, Native American Church, Elder Center Activities, Drum Services, Language & Culture Classes and other religious/spiritual activities.

Services currently monitored for quality and effectiveness: Participants are monitored by their continuous sobriety, attendance in continuing care groups, weekly HTWC attendance, completed activity certificates, parent class completion, anger management class completion, stable employment, adequate housing and education.

The Prairie Band Potawatomi Nation will come together to be a substance free community, free of violence and abuse, by continuing the preservation of our language and culture, unifying our families and thereby securing our future.

community and


families with culturally appropriate services through collaborative partnerships. Individuals and families will be encourage through education, treatment, and intense supervision to effect long term positive lifestyle changes, thereby creating a culturally enriched healthy community.

Eligibility requirements/Criteria for acceptance include:

- 1. Any alcohol related offense.
- 2. Any drug related offense.
- 3. Alternative Sentencing. A participant has plead guilty or been convicted in the District Court. As part of the sentencing hearing, the Court will announce the sentence (jail time, fines, community service, banishment, etc.)
- 4. Diversion Agreement. A participant enters an agreement with the prosecution that the participant will enter HTWC in exchange for the prosecution diverting the charges.
- 5. Special plea or no contest.

 Participant does not agree to facts, (s) he acknowledges that there are charges pending, and proceeds to HTWC.
- 6. Voluntarily consent to be a participant.
