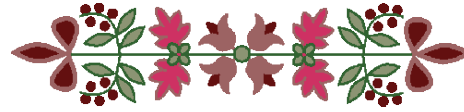

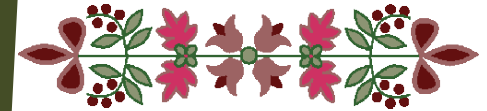

# Hemp Regulation

Federal Law Definition of Hemp in 2018 Farm Bill

“The term ‘hemp’ means the plant Cannabis sativa L. and part of the plant, including the seeds thereof and all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3 percent on a dry weight basis.”

PBPN/United State Department of Agriculture/ Tribal Hemp Plan/ December 19, 2019. On 2/20/2020 USDA approved PBPN’s Hemp Plan allowing the Tribe authority to administer a domestic hemp program under the oversight of the USDA Domestic Hemp Production Program.

Prairie Band Potawatomi Nation Tribal Council Resolution PBP 2020-141, amended Title 32, Potawatomi Law and Order Code Title 32 Hemp Legalization and Control and delegated the PBPN Tax Commission to oversee the regulation of Hemp including but not limited to the following:

License Eligibility, Application and Process, Approval/Denial, Suspension/Revocation, Compliance, Sampling, Testing, Disposal, Inspections, Audits, Violations, and Reporting, Record keeping.

The Applicant must first make application which includes: Name, address, phone no., Background questions, production area information; Legal Description, Field or Building, Acreage/sq. footage of production area, Geospatial Location w/ coordinates, includes a map, Anticipated Planting date, Anticipated Harvest Date and Criminal History information.

### **Fees per application:**

**\$250 for 0-39.99 acres + \$5 an acre.  
\$500 for 40-80 acres +\$5 an acre.**

**Fees are per application and all applications fees will be non-refundable.  
Acreage fees are refundable.**
